PRECAUTIONARY/PREPAREDNESS ACTIONS...

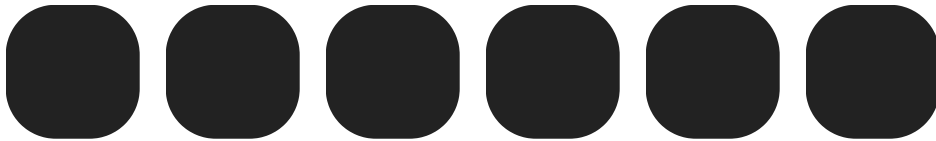

... THE NATIONAL WEATHER SERVICE IN PADUCAH HAS ISSUED A WIND ADVISORY, WHICH IS IN EFFECT FROM 10 PM THIS EVENING TO 1 PM CDT MONDAY.

* TIMING...LATE THIS EVENING THROUGH MONDAY MORNING.

* WINDS...SUSTAINED WINDS OF 20 TO 25 MPH WITH GUSTS OF 40 TO 45 MPH.

* IMPACTS...GUSTY WINDS COULD BLOW AROUND UNSECURED OBJECTS.

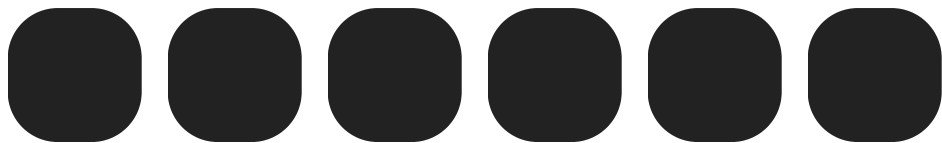

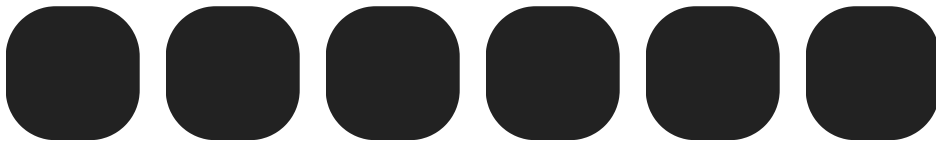
Stoddard County, MO - The National Weather Service in Paducah, Kentucky has issued a Flood Advisory for Stoddard County, MO.

STODDARD COUNTY IN SOUTHEASTERN MISSOURI... * UNTIL 730 PM CDT. * AT 528 PM CDT, A LARGE AREA OF HEAVY RAIN AND THUNDERSTORMS WAS MOVING NORTHEAST ACROSS THE ADVISORY AREA. THE AREA EXTENDED BACK INTO NORTHEAST ARKANSAS. THIS WILL CAUSE MINOR FLOODING IN THE ADVISORY AREA. * SOME LOCATIONS THAT WILL EXPERIENCE FLOODING INCLUDE... SIKESTON, DEXTER, SCOTT CITY, PORTAGEVILLE, NEW MADRID, CHAFFEE, BERNIE, BLOOMFIELD, AND BENTON. PRECAUTIONARY/PREPAREDNESS ACTIONS... 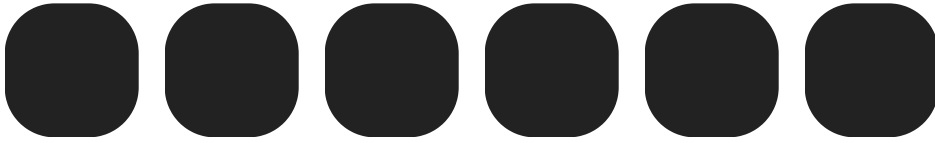

SOUTHEASTERN STODDARD COUNTY IN SOUTHEASTERN MISSOURI... * UNTIL 545 PM CDT. * AT 501 PM CDT, A SEVERE THUNDERSTORM WAS LOCATED OVER CAMPBELL, MOVING NORTHEAST AT 65 MPH. HAZARD...60 MPH WIND GUSTS AND QUARTER SIZE HAIL. SOURCE...RADAR INDICATED. IMPACT...HAIL DAMAGE TO VEHICLES IS EXPECTED. 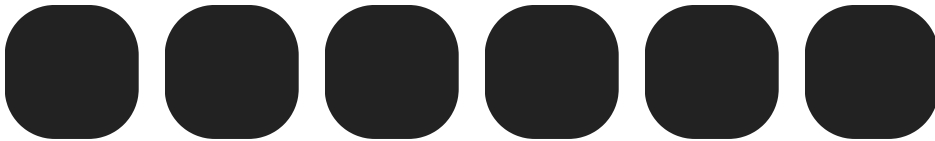

Stoddard County, MO - The National Weather Service in Paducah, KY has issued a Flash Flood Watch effective through Friday morning for Stoddard County, Missouri.

...FLASH FLOOD WATCH IN EFFECT THROUGH FRIDAY MORNING

... THE NATIONAL WEATHER SERVICE IN PADUCAH HAS ISSUED A * FLASH FLOOD WATCH FOR THE ENTIRE QUAD STATE REGION OF SOUTHERN ILLINOIS, SOUTHWEST INDIANA, WESTERN KENTUCKY, AND SOUTHEAST MISSOURI. * THROUGH FRIDAY MORNING *

MULTIPLE ROUNDS OF HEAVY RAINFALL WILL BE FALLING ON SATURATED OR NEARLY SATURATED GROUNDS. AND WITH CREEKS AND STREAMS ALREADY SWOLLEN, MUCH OF THIS RAINFALL WILL BECOME RUNOFF, CAUSING FLOODING ISSUES AND POSSIBLE FLASH FLOODING WHERE STORMS BRING THE HEAVIEST RAINS.

* LOW LYING AREAS AND LOW WATER CROSSINGS WILL BE THE FIRST TO FLOOD WHEN IT RAINS. MULTIPLE ROUNDS OF RAINFALL, HEAVY AT TIMES, WILL LIKELY EXPAND THESE USUAL FLOOD PRONE AREAS, TO INCLUDE MORE EXPANSIVE, GENERAL ROAD FLOODING. CREEKS AND STREAMS ALREADY AT BANKFULL WILL FURTHER HEIGHTEN THE FLASH FLOODING HAZARD AS ADDITIONAL HEAVY RAINS OCCUR. PRECAUTIONARY/PREPAREDNESS ACTIONS...

A FLASH FLOOD WATCH MEANS THAT CONDITIONS MAY DEVELOP THAT LEAD TO FLASH FLOODING. FLASH FLOODING IS A VERY DANGEROUS SITUATION. YOU SHOULD MONITOR LATER FORECASTS AND BE PREPARED TO TAKE ACTION SHOULD FLASH FLOOD WARNINGS BE ISSUED.
