Portions of southern Illinois, southwest Indiana, western Kentucky and southeast Missouri

...WIND ADVISORY IN EFFECT FROM 4 AM CDT/5 AM EDT TO 4 PM CDT/5 PM EDT WEDNESDAY...

WHAT...South winds 15 to 25 mph with gusts up to 40 mph expected.

WHERE...Portions of southern Illinois, southwest Indiana, western Kentucky and southeast Missouri.

WHEN...From 4 AM to 4 PM Wednesday

IMPACTS...Gusty winds could blow around unsecured objects. Tree limbs could be blown down and a few power outages may result.

ADDITIONAL DETAILS...Winds will be locally much stronger in any severe thunderstorm activity.

WHAT...Southwest winds 20 to 30 mph with gusts up to 50 mph expected.

WHERE...Portions of southern Illinois, western Kentucky and southeast Missouri. The advisory is along and west of a line from Mount Vernon to Marion Illinois, then to Paducah and Murray Kentucky.

WHEN...From 1 PM Friday to 1 AM CDT Saturday.

IMPACTS...Gusty winds could blow around unsecured objects. Tree limbs could be blown down and a few power outages may result.

ADDITIONAL DETAILS...Locally stronger winds are possible in thunderstorms Friday afternoon and evening.

southwest Indiana, Gibson, Pike, Posey, Spencer, Vanderburgh and Warrick. In western Kentucky, Ballard, Carlisle, Crittenden, Daviess, Henderson, Livingston, McCracken, McLean, Union KY and Webster. In southeast Missouri, Bollinger, Butler, Cape Girardeau, Carter, Mississippi, New Madrid, Perry MO, Ripley, Scott, Stoddard and Wayne MO

In southeast Missouri, Bollinger, Butler, Cape Girardeau, Carter, Mississippi, New Madrid, Perry MO, Ripley, Scott, Stoddard and Wayne MO.

WHEN...Through late Friday night.

IMPACTS...Excessive runoff is expected to result in flooding of rivers, creeks, streams, and other low-lying and flood-prone locations. Creeks and streams may rise out of their banks. Some areas may experience more widespread and significant flash flooding with road closures and washouts, water entering normally dry areas, and dangerous travel conditions.

ADDITIONAL DETAILS... - Periods of rain and thunderstorms are forecast to begin tonight and persist through Friday night. 2 to 4 inches of rain is expected over the region and locally higher amounts are possible. -

A few power lines may be knocked down, but damage to powerlines is more likely through trees and limbs falling. Numerous power outages are possible.
