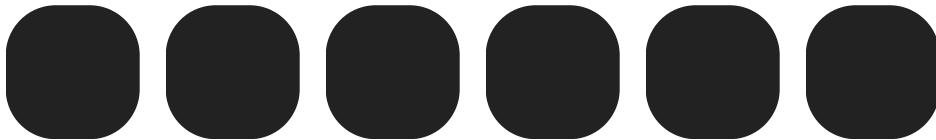

She is survived by one son, Robert Stoker of Bloomfield: by two daughters, Paula Stoker

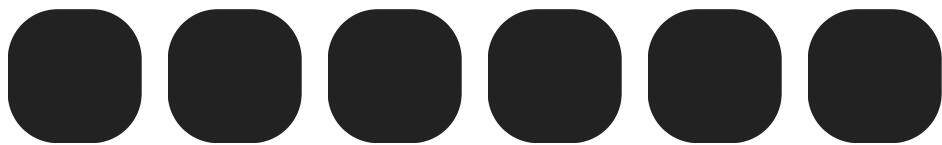
