From the time she moved to California until she moved into Crown Pointe, Ethelyn was fiercely independent. After she arrived in California she worked for a variety of companies, including Prudential, Armstrong Nurseries, and ultimately General Telephone Company (now a part of Verizon). She retired in 1980. Ethelyn caught the travel bug early and over her lifetime traveled extensively throughout Europe. She fell in love with cruising taking seventeen separate cruises. Her traveling companion for many years was Don Leaman whom she had met at Armstrong Nurseries in 1948. From the Mexican Riviera to Asia to the Caribbean, cruising was her favorite pastime. As a member of the Red Hat Society in Murrieta, Ethelyn was the Matriarch of the club. She was also a member of the Rancho Community Church in Temecula, a member of the Ambassadors Class and hosted a study group in her home at the age of 92.

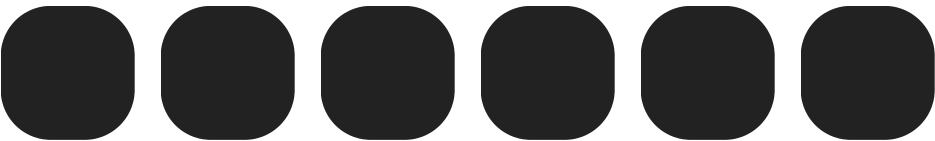
