Besides his parents and his wife, he was preceded in death by four brothers.

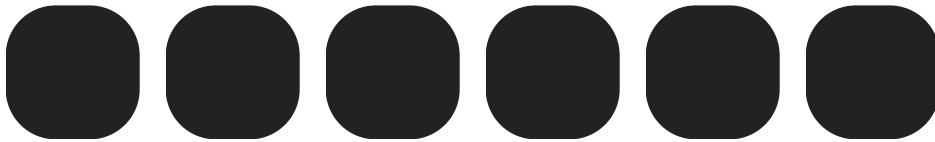
