A private family visitation will be held on Friday, October 5, 2012, at 6:00 PM at the Watkins and Sons Funeral Home in Dexter, Missouri.

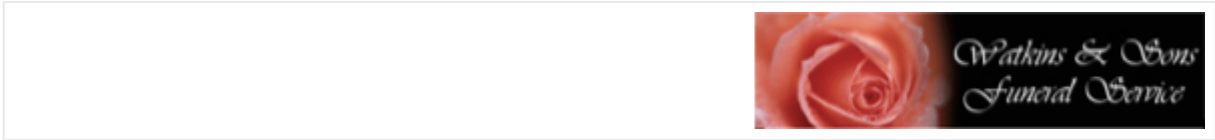
Funeral services will be held on Saturday, October 6, 2012 at 1:00 PM at the Watkins and Sons Funeral Home in Dexter, Missouri.

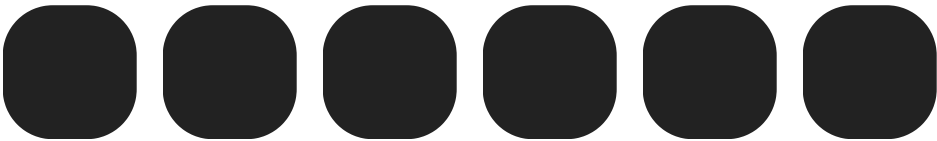

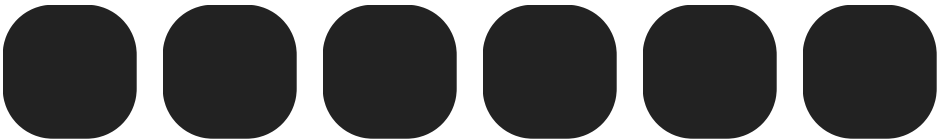
