A response to your testimony will be provided in the Final Environmental Impact Statement. There will be a five minute limit on all statements during the public meetings to allow all participants an opportunity to speak.

Information regarding statements for the record: If attendees wish to make a statement for the record outside of the public meeting, written comments can be officially submitted to USACE staff any time during the open house or after the

public meeting. A response to all testimony will be provided in the Final Environmental Impact Statement on the project.

The entire public meeting and any statements made for the record will be transcribed after the meeting and posted to the St. Johns Bayou and New Madrid Floodway Project web site.


