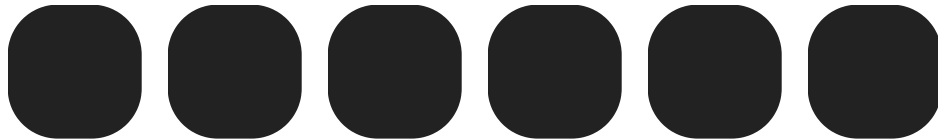
Visitation will be held on Saturday, April 5, 2014, from 12:00 to 2:00 p.m. at Rainey-Mathis Funeral Home in Dexter.

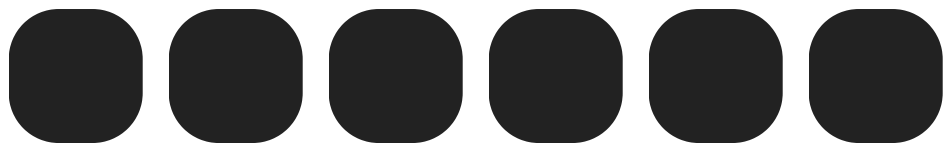
