Funeral services will be held on Tuesday, May 20, 2014, at 10:00 a.m. at the Parma General Baptist Church in Parma, Missouri.

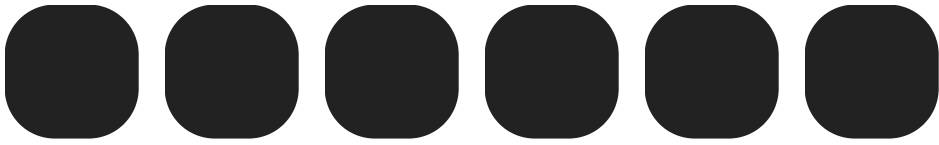
