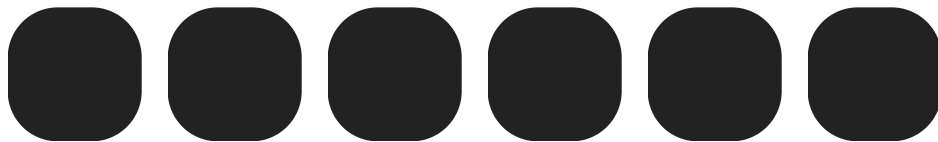
At 6:00 P.M. on Tuesday, February 24, 2015 Dr. Barry Winders will give a few remarks.

Interment will be in the Walker Cemetery in Bloomfield, Missouri with Chiles-Cooper Funeral Home of Bloomfield in charge of arrangements.

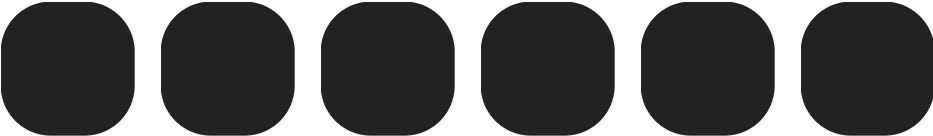
