Funeral services will then be conducted in the Rainey-Mathis Funeral Chapel starting at 2:30 P.M. with Rev. Don Wells officiating.

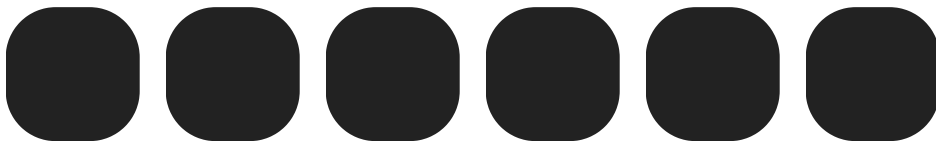

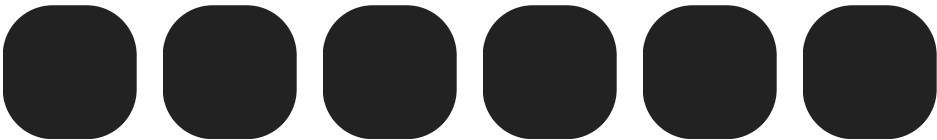
