Friends may call at the Rainey-Mathis Funeral Home in Dexter from 11:30-2:00 P.M. Tuesday, May 12, 2015.

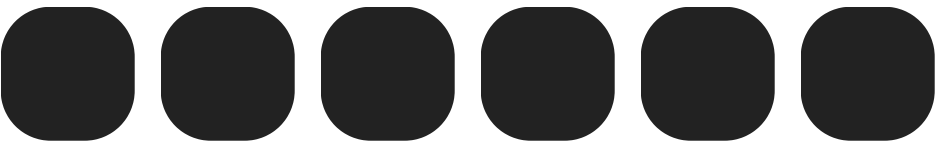
