Chapel in Dexter, Missouri with Rev. Lewis Scott of Marble Hill, Missouri officiating.

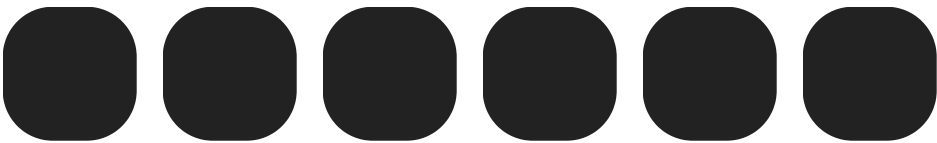

In addition to her husband and parents, she was preceded in death by one brother, Joseph Leo Tibbs; and by one sister, Ruby Elaine Hurley.

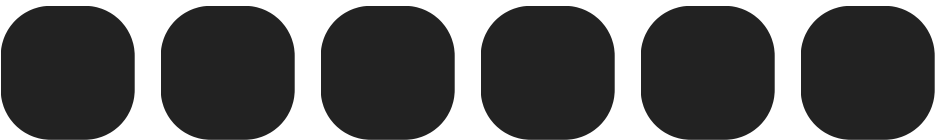
