After the deadline, late entries will be accepted with an additional \$5.00 charge.

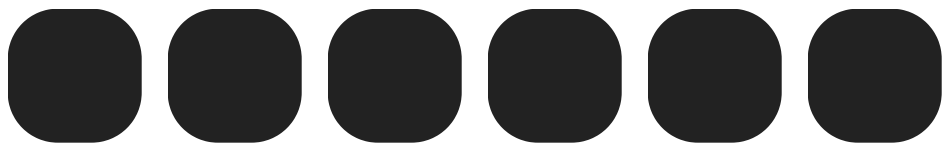

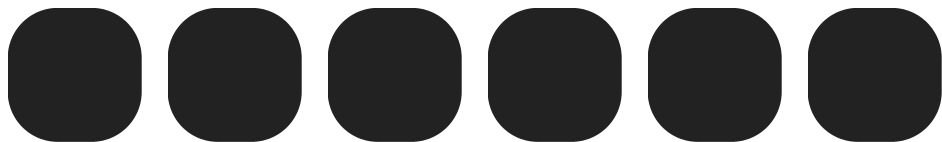
The Stoddard County Nutrition Center will hold their annual Quilt Exhibit during the festival.

Jarrell was appointed by Gov. Eric Greitens to finish the term of Judge Steve Mitchell who retired in early September.

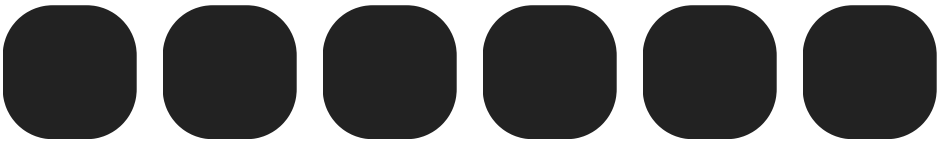
He used his grandfather's Bible for the ceremony which was attended by several friends and family.

Modern Woodmen will also donate a \$100 in Bill's honor to Stoddard County Children's Home, Charity of his Choice.

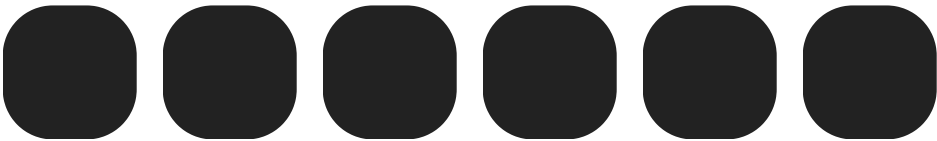
They salute Bill and appreciate his donuts across Stoddard County on Fridays!
