## 2019 Voting Underway for County Extension Council

Voting for the members of the Stoddard County Extension Council has begun and will continue through January 29, 2019.

All Stoddard County citizens age 18 or older are eligible to vote.

This year we have four candidates running: Keith Baker, Jackie Harmon, Logan Lowery, and Jennifer Murphy.

Paper ballots will be available at the Extension Office, located at 316 S. Prairie Street in Bloomfield. Voting may be done by coming to the Extension Office and requesting a 2019 ballot. Extension Office hours are 8:30 a.m. to 4:30 p.m. for voting. **You may also vote online by going to our county Extension website by clicking [HERE](#).**

The Stoddard County University of Missouri Extension Council determines the educational programs, policies and approves staff of University Extension for Stoddard County as set by law. In addition, in cooperation with the Stoddard County Commission, they arrange for financing the local portion of the programs.

Some of the educational programs available through University Extension in Stoddard County deal with large scale agriculture and small scale farming enterprises, home economics, community development, horticulture, continuing education, 4-H and youth development, business development, homemaker clubs and foods and nutrition for low-income families. These programs, open to all citizens, are provided by county area-based

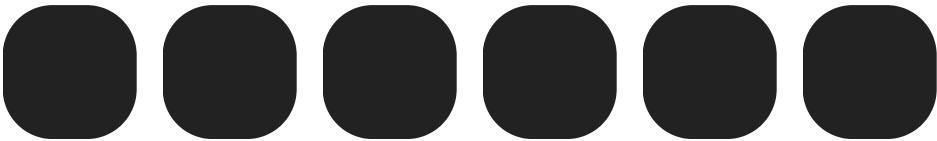
and campus based specialists and paraprofessionals through the University of Missouri and Lincoln University.

Pictured is Senator Libla addressing the full room of Kiwanis members and guests.

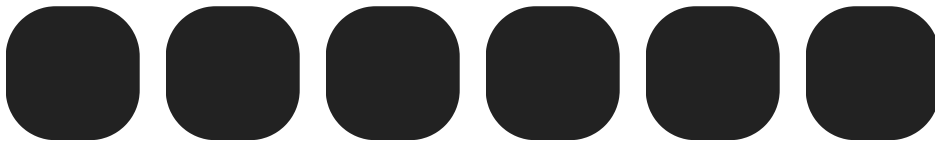
Senator Libla gave a brief update and then fielded questions from those attending.

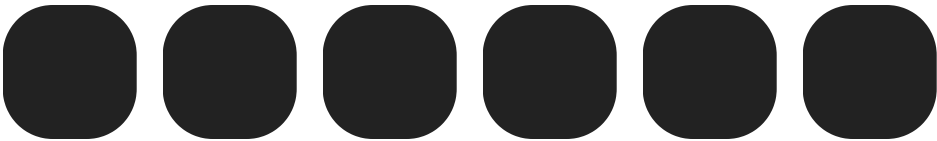
Anyone interested in bidding the job should be in attendance at the commission chambers.

He was driving a 2019 gray/silver Nissan frontier truck with Louisiana plate Y293967

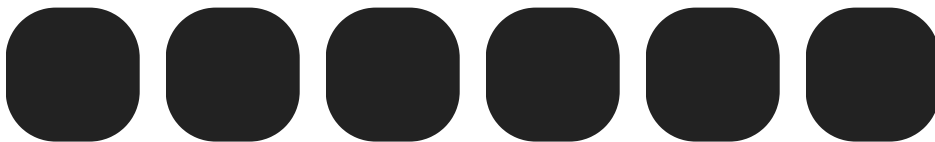
