Missouri to Hold Presidential Primary on Tuesday, March 10, 2020 - Voting Locations for Stodday

Missouri voters will head to the polls Tuesday for the presidential preference primary election. Here's where and when to find the polls in the area.

According to the Missouri Secretary of State's website, all polling locations across the state are open from 6 a.m. to 7 p.m. on Election Day. Voters in line at closing time have the right to cast votes.

Dexter Wards One, Two, and Three will now vote at the Bearcat Event Center. Dexter Rural will vote at the Sacred Heart Catholic Church Prish Center.

## Dexter PD Narcotics Enforcement Operation Results

Dexter PD Narcotics Enforcement Operation Results

On 02/07/2020, the Dexter Police Department, assisted by the SEMO Drug Task Force, Stoddard County Sheriff's Department and the Missouri State Highway Patrol, conducted a targeted narcotic enforcement sweep in the City of Dexter. The operation began at 1800 hours on 02/07/2020 and concluded at 0600 hours on 02/08/2020. During the operation, Officers conducted 95 traffic stops and conducted 11 residence checks targeting narcotics and drug paraphernalia. During these enforcement stops and residence checks, Officers made 17 custodial arrests and issued 22 citations. The following is a breakdown of the individual arrests made during the operation.

This operation was conducted as a result of months of narcotics investigations and tips from the public.
