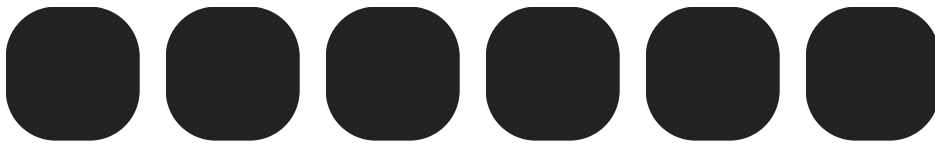
Besides his mother he was preceded in death by one brother, Ricky Fry.
