Her son, Todd Crumley, will officiate.

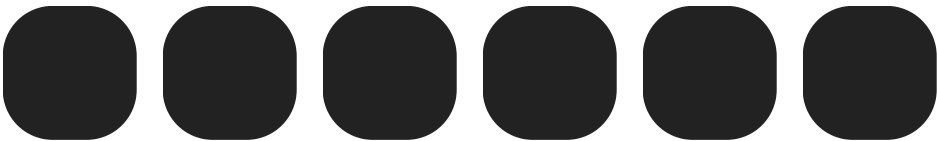
Interment will follow in the Dogwood Cemetery near East Prairie under the direction of the McMikle Funeral Home of Sikeston.

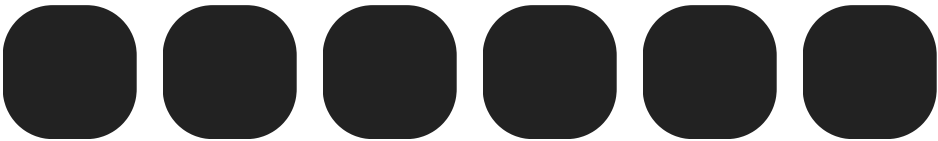
