Hunt positions will be pre-assigned.

No poor line or vacancy filling.

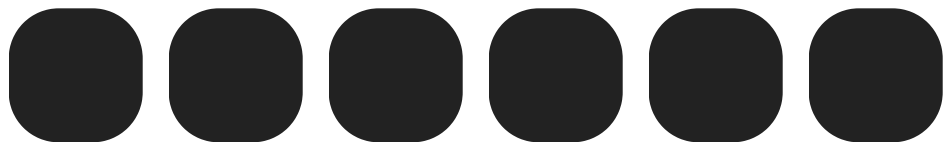

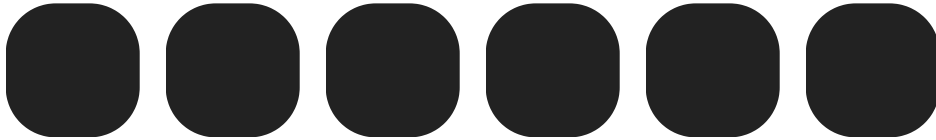

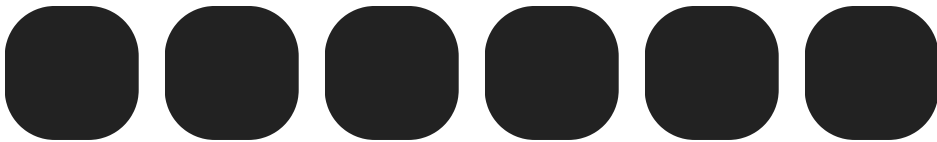

Semifinal matches will be TBA depending on which schools win.

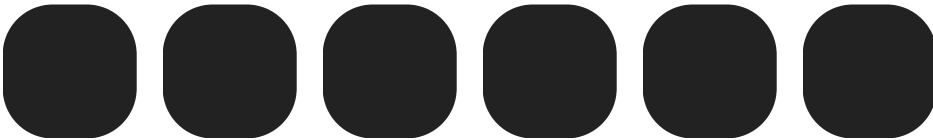
Third Place game and Championship games are set for Friday night.
