### Dexter Wrestlers Headed to 2021 State Tournament

Ste. Genevieve, MO - Eric Harmon, Diego McCormick and Alex Townsend from Dexter High School wrestling team qualified for the state tournament Saturday at Ste. Genevieve High School. The three Bearcats will advance to the MSHSAA Class 2 Wrestling Championships set for March 11, 2021 at Cable Dahmer Arena in Independence, Missouri.

Diego McCormick placed 3rd at 113 lbs, Eric Harmon 3rd at 120 lbs, and Alex Townsend was Sectional Champion at 170 lbs.

The top three finishers in each weight class at Saturday's sectional tournament advanced to state.
