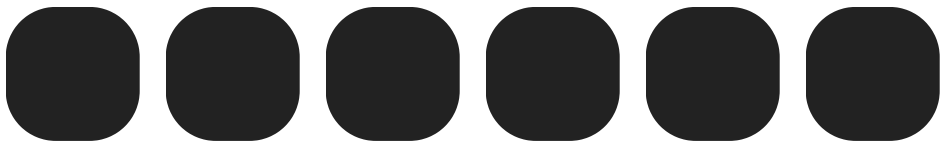

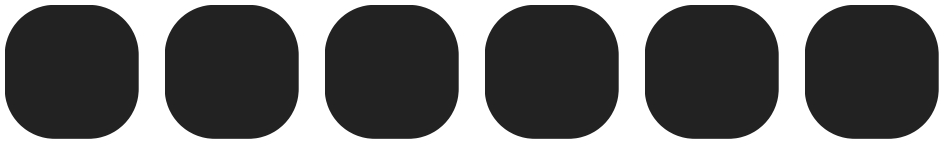

 - B. Nurse's Report

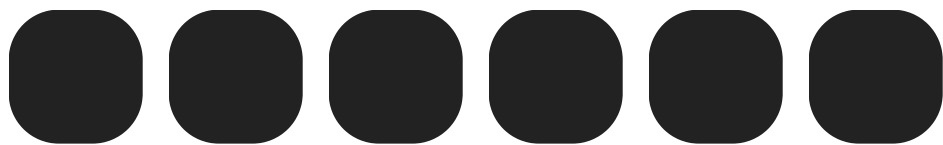

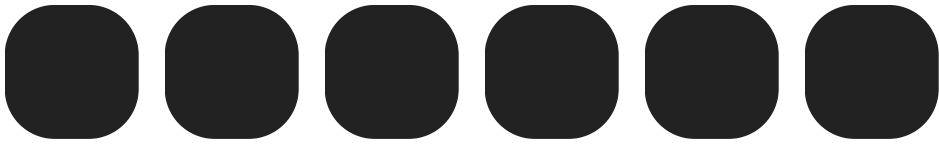
