Virginia along with her husband worked along with the county extension agents for eight years and would eventually organize a 4-H club, which would be named, "Town and Country" to join together kids from town as well as the country. They taught cooking, cattle, swine, sewing, horsemanship, breads, gardening, bicycles and numerous other classes in the homes. All of their children would be awarded trips to Washington, D.C. through the organization.

As an accomplished quilter, Virginia was a member of the Heartland Quilt Guild in Dexter and served as President, Historian and Reporter through the years. Her many beautiful quilts will remain heirlooms for years to come.


Interment will follow in the Chalk Bluff Cemetery, south of Dexter, Missouri.

Mrs. Newberry was a homemaker.


On October 18, 1994 she was united in marriage to Alvin Newberry in Gulfport, Mississippi. Mr. Newberry survives of their home in Bloomfield.

Mr. Ockel was the former warehouse manager for Federal Mogul and he was a resident of Dexter.


