Dudley, MO - MoDOT plans to replace the deck of the Route WW bridge over Drainage Ditch #26 in Stoddard County. The bridge is located between County Road 420 and County Road 436, north of Dudley, Mo.

Construction could begin as early as spring 2022, with completion anticipated by fall 2022.

As work is underway, the roadway will be closed in the vicinity of the bridge for approximately three months. Motorists should seek alternate routes during the bridge closure.


There is also a drop box available 24/7 for your convenience. It is located at the government building on the north side of the double door main entrance.
