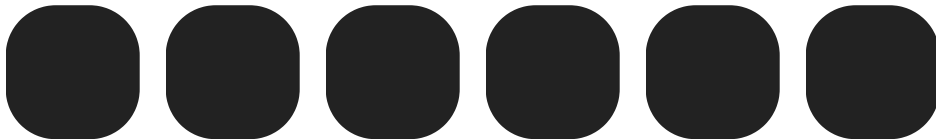
Interment will follow on Sunday, February 20, 2022, at 9:00 a.m. in the Walker Cemetery in Bloomfield.

Funeral services will then be conducted in the Mathis Funeral Home Chapel on Thursday, February 17, 2022, at 10:00 a.m.

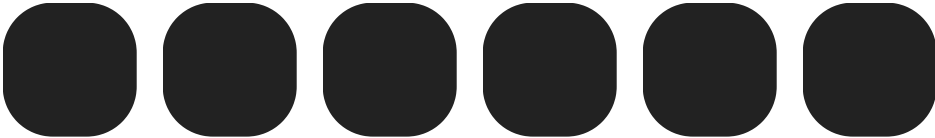
