If the matter cannot be resolved with the Assessor's Office, an appointment to meet with the Board of Equalization will be set up by the County Clerk's Office.

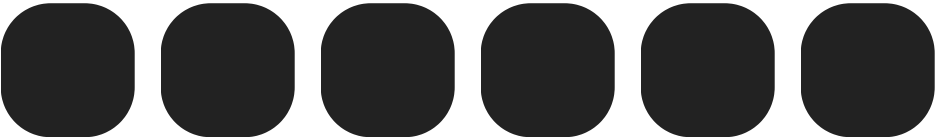
