Visitation will be held at Mathis Funeral Home in Dexter on Thursday, August 4, 2022, from 10:00 a.m. until 12:00 p.m.



Paula was married to Jerry Busby until his passing and then married Jerry Johnson and was married until his passing.



Mrs. Newell was a resident of Dexter. She had worked as a bookkeeper and was also a licensed nurse.


On May 27, 1983, she was united in marriage to Robert "Bob" Newell in Oxnard, California. Mr. Newell preceded her in death on April 6, 2022.
