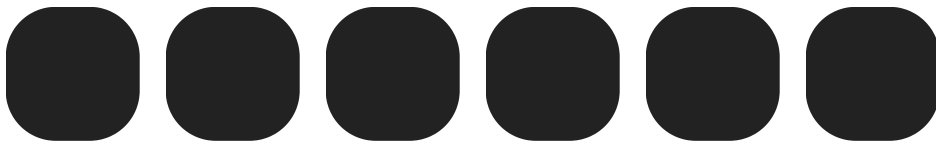
Interment will follow in the Hobbs Chapel Cemetery, in Puxico, Missouri.

Funeral services will then be conducted at 1:00 P.M. in the Sunnyvale Chapel with Rev. James Hamlett officiating.

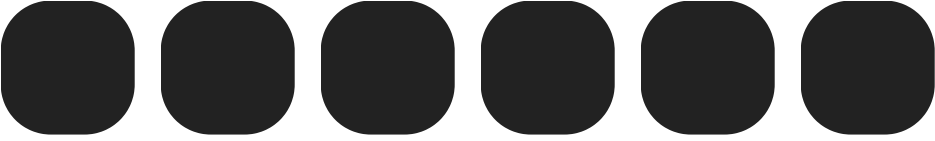
