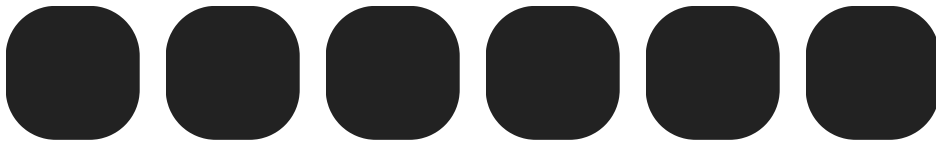
Other than his parents, Kenny was preceded in death by his brother Keith Hill; and by his sister, Debbie Hill.
