A Celebration of Life will be held on Saturday, October 19, 2024, with a place and time to be announced.

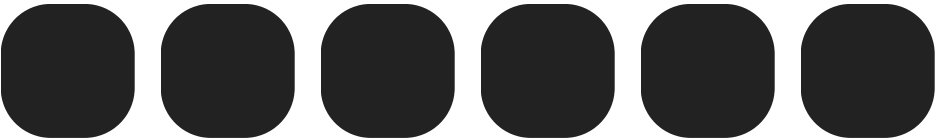

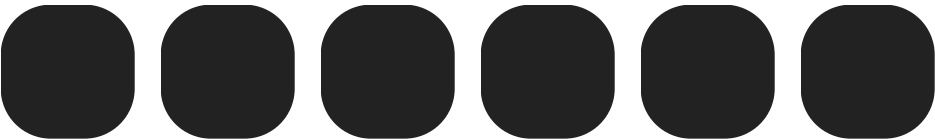

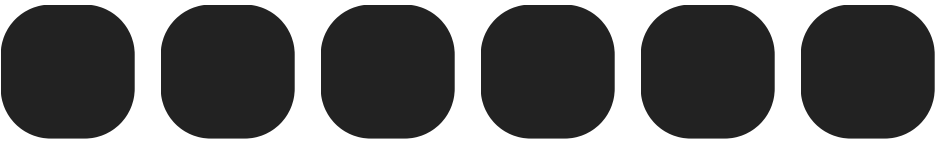
